

Subject: Guideline for stamping a visa extension stamp for an alien who has been permitted a temporary stay in the Kingdom in accordance with the Notification of the Ministry of Interior regarding Permission for certain groups of aliens to remain in the Kingdom as a special case issued on 7 April B.E. 2563 (2020) and its amendments

To: Immigration Commanders

Pursuant to the Notification of the Ministry of Interior regarding Permission for certain groups of aliens to remain in the Kingdom as a special case issued on 7 April B.E. 2563 (2020) extending the period of time permitted for stay in the Kingdom under Section 35 of the Immigration Act B.E. 2522 (1979) or in accordance with the relevant notifications for aliens who have been permitted a temporary stay in the Kingdom as from 26 March B.E. 2563 (2020) to 26 September B.E. 2563 (2020);

Due to aliens permitted to stay in the Kingdom in accordance with the Notification of the Ministry of Interior have no valid visa stamp in a passport to use as an evidence for contacting with government sectors or making other transactions. Therefore, a local immigration official where an alien has a domicile or workplace shall stamp a visa extension stamp in accordance with the Notification of the Ministry of Interior in an alien's passport and remark "An alien as stated in the Notification of the Ministry of Interior COVID-19 dated 7 April 2563 (2020) and its amendments" below the visa extension stamp as per attached example.

Please be informed and proceed accordingly.
