## Order of Immigration Bureau no. 312 /2564

Subject: Amendment to Supporting Documents for Consideration of an Alien's Application for a Temporary Stay in the Kingdom

Pursuant to the Order of Immigration Bureau no.138/2557 dated July 7, 2014 concerning the Supporting Documents for Consideration of an Alien's Application for a Temporary Stay in the Kingdom, additionally amended by the order of Immigration Bureau no.300/2562 dated September 27, 2019 concerning the Amendment to Supporting Documents for Consideration of an Alien's Application for a Temporary Stay in the Kingdom,

It is deemed expedient to amend the Supporting Documents for Consideration of an Alien's Application for a Temporary Stay in the Kingdom in compliance with the Cabinet Resolution as of June 15, 2021 approved in principle to amend the criteria for purchasing health insurance of aliens applying for Non-Immigrant "O-A" Visa. (not exceeding 1 year)

By virtue of Article 2 of the Order of Royal Thai Police no.327/2557 dated June 30, 2014 concerning the Criteria and Conditions for Consideration of an Alien's Application for a Temporary Stay in the Kingdom, to repeal the Order of Immigration Bureau no.300/2562 dated September 27, 2019 concerning the Amendment to Supporting Documents for Consideration of an Alien's Application for a Temporary Stay in the Kingdom and prescribe the Supporting Documents for Consideration of an Alien's Application for a Temporary Stay in the Kingdom, according to the reason of necessity no.2.22 attached to this order.

This order is effective as of October 1, 2022.
